



## **INFORMATION OBLIGATION – GDPR**

Due to the entry into force of the Regulation of the European Parliament and of the EU Council on the protection of natural persons with regard to the processing of personal data and on the free movement of such data (GDPR) of 27/04/2016 and the growing value of information, especially personal data, Nazar Sp. z o. o. SK based in Leźno is aware of the importance of threats related to the data processing process and declares to take systematic actions to prevent threats to information security, the occurrence of which may lead to the loss of confidentiality, integrity and accountability of data, and in particular to disclosure of information to unauthorized persons, damage or destruction.

To guarantee the above declaration, the Company strives to achieve a satisfactory level of security of processed information by:

- Confirmation of the need to protect information, in particular data processed in IT systems.
- Provide support for information security initiatives.
- Providing the resources needed to implement the required security measures.
- Placing special supervision over all documentation containing customers' personal data.
- Ensuring activities to shape the awareness of employees/collaborators as to the importance and importance
  of processed data, including personal data.

## At the same time, we would like to inform you:

- I. Pursuant to Art. 13 section 1 and section 2 of the General Regulation on the Protection of Personal Data of April 27, 2016 (Journal of Laws L 119/1, 4/05/2016), the controller of the Personal Data Protection Office and the recipient of your personal data is Nazar Sp. z o. o. SK based in Leźno.
- II. Your personal data will be processed for the purposes of:
  - providing information about the current offer
  - providing information about promotions
  - other marketing activities regarding products offered by Nazar Sp. z o. o. SK.
- III. At any time, you have the right to access your personal data and rectify it, delete it, limit its processing, the right to transfer data, the right to object and the right to withdraw previously expressed consent to the processing of personal data. Withdrawn consent at any time does not affect the lawfulness of data processing carried out on the basis of this consent before its withdrawal.
- IV. You have the right to lodge a complaint with the supervisory authority if you consider that the processing of your personal data within the scope of this consent violates the provisions of the General Data Protection Regulation of April 27, 2016 (Journal of Laws L 119/1, 4/05/2016)
- V. Your personal data will be transferred to other processing entities with which Nazar Sp. z o. o. SK, as part of its business activities, is obliged to provide your personal details contained in sales documents as part of the execution of orders.





- VI. Your personal data will not be transferred to a third country/international organization.
- VII. Personal data will be processed no longer than until the consent to the processing of your personal data is withdrawn or for another period regulated by law, where applicable.
- VIII. - IX. Providing personal data is voluntary, but failure to do so will prevent us from contacting you and fulfilling orders.
